* The fee includes boarding, lodging, laundry, routine on-site medical attention, free email and web access.

** Those who wants to apply for Arjuna Tennis Program have to pay Rs.60,000 annually.

** Horse Riding is compulsory for Classes 5th to 8th and optional for Classes 9th to 12th.

*** Processing fee is applicable for students having foreign passports.

Overseas/Afro Asian student is defined as a person who holds citizenship of countries other than India and SAARC countries. Students from SAARC countries may pay in INR or equivalent amount in USD.

Imprest account caters to expenses such as medical, pocket money, books and stationery, uniform, excursions and special coaching. Items supplied by the school at cost are adjusted against this account.

All fee and charges are to be paid by NEFT Transfer, 'Pay order' or 'demand draft' in favor of 'SelaQui International School' Payable at Dehradun. Payment by cheque is not acceptable.

Fee for coming academic year becomes payable on 1st Feb every year and may be paid by 28th Feb, in full. However, the school accepts payment of fee in two equal halves, i.e. as on 1st Feb payable by 28th Feb for the 1st term and as on 1st Aug payable by 31st Aug for the 2nd term.

Penalty, as given below, is levied if fees are not paid on time.

If the fees or imprest are not paid in accordance with the stipulated date, a fine of 3% of outstanding fee and other dues, per month, will be imposed. No credit facilities will be extended to such students unless all their dues have been cleared.

Any delay beyond 2 months of the fee becoming due may lead to the name of student being struck off the school rolls. If parents wish their ward to continue, it shall be treated as fresh admission. It will be mandatory for parents to clear the impress bill of their wards regularly and a balance of Rs.50,000 has to be maintained in the beginning of each term. Under no circumstances it should fall below Rs.10,000 at any point of time.

If a child is withdrawn from the school at any time, the following rules apply:

- 1. Notice of withdrawal must be given at least 90 days prior to the end of academic year (before December 31st). There will be a fine of Rs. 50,000 (US\$ 1000 for overseas students) for a shorter notice period or when the student is withdrawn mid-session.**
- 2. If a child is withdrawn or asked to leave for any disciplinary issues once term starts, full fee for the term shall become payable. None of the fee is refundable except the amount left in imprest and the caution money.**
